Ingredients

3-5 standard-size Hershey's milk chocolate bars 1 bag large marshmallows Graham crackers, pretzels or fresh fruit for dipping

Instructions

Preheat oven to 400 degrees. Grease skillet or shallow pan and cover the bottom of the pan with the chocolate bars. Put the chocolate in the oven for about 3 minutes to start melting. Remove pan from oven and top with marshmallows, standing them on the flat side and covering the entire top in a single layer. Bake for 5-7 minutes or until the marshmallows are puffed and golden. Serve hot with dippers.
